**Club Member Release - Assumption of Risk Agreement**

I, \_\_\_\_\_, hereby acknowledge that I have voluntarily applied to enter onto and to engage in or observe shooting and other activities at the shooting range facility (the "RANGE") of Hat Creek Rifle & Pistol Club, Inc., (the "CLUB"). These activities include, but are not limited to, the use and discharge of firearms at the RANGE.

I acknowledge and understand that shooting activities are inherently hazardous and involve both known and unanticipated risks which could result in damage or destruction of property and physical or emotional injury, including paralysis or death, of myself or of persons. These risks include but are not limited to: being shot by or shooting myself or others resulting in my death; partial or total loss of eyesight or hearing; inhalation or other harmful contact with lead or other contaminants; and being struck by flying or falling objects. I further understand that the discharging of firearms and the use of ammunition have inherent dangers that no amount of care, instruction, or expertise can eliminate.

I further acknowledge and understand that the RANGE is an outdoor shooting facility, which could result in ricochets which could cause serious personal injury or death to myself or others.

I further acknowledge and understand that CLUB makes no warranty as to the design, manufacture, condition, or fitness for any purpose of any RANGE facilities or equipment, including, but not limited to: firearms, ammunition, eye/hearing protection, and first aid supplies. The CLUB makes no warranty to medical personnel on site.

I represent that I have never been convicted of a felony. California law prohibits any person convicted of a felony to be present in any environment where firearms are present. I represent that I am knowledgeable and skilled in the proper handling, loading, use and discharge of all firearms and ammunition I intend to use at the RANGE. I understand that the RANGE is specifically relying on the truth of my representations concerning my knowledge and skill with firearms, in permitting me to make use of the RANGE.

**As lawful consideration for being permitted by the CLUB to enter onto the RANGE, to use RANGE facilities or equipment and to engage in or observe shooting and other activities at the RANGE, as either a Member or Guest, I agree as follows:**

I agree to assume full responsibility for all risks, injuries, or damages, known or unknown, of whatsoever any kind and nature, which I might incur because of entering onto the RANGE and in using RANGE facilities or equipment and in engaging in or observing shooting and other activities at the RANGE.

I agree to assume all responsibility and liability for any act or acts, negligent, reckless, or criminal act or omission to act, of my Guests at the RANGE. I understand that "my Guests" includes all persons who



enter onto the RANGE, use the RANGE facilities or engage in or observe shooting and other activities at the RANGE because of my express invitation. I agree that I will ensure that each of my Guests read and sign a "Release- Assumption of Risk Agreement." Guests also include any minors under guardianship of the undersigned (MINOR is defined as any person under the age of 18 on the date the activities on the RANGE are to take place). Each MINOR participating in RANGE activities must be included in the GUARDIANSHIP section at the bottom of this document and is therefore also bound by "Release- Assumption of Risk Agreement."

I agree to abide by CLUB's Range Rules and to ensure my Guests do so as well. I knowingly, voluntarily, and expressly waive any and all claims I, my next of kin, heirs, guardians, representatives, assigns or any other person claiming under me completely and without reservation that I may have against the CLUB, its agents, officers, members, employees, instructors, volunteers, or representatives from any and all injuries or damages that I may sustain as a result of me entering onto the RANGE, using RANGE facilities or equipment, or engaging in or observing shooting range activities. Also I, my next of kin, heirs, guardians, representatives, assigns or any other person claiming under me, forever release, waive, discharge and covenant not to sue the CLUB, its agents, officers, members, employees, instructors, volunteers, or representatives for any personal injury, death, disability, property damage, property theft, or acts and/or omissions of whatsoever kind and nature including, but not limited to, those caused by its negligence or other acts including but not limited to, those acts and/or omissions of other participants or persons at the RANGE. I further acknowledge and agree that it is my understanding and intent that this Agreement, and any signed written amendments or modifications to it, shall remain in full force and effect from the date of execution and ever after shall be applicable to each and every occasion that I or my Guests enter onto the RANGE, use RANGE facilities or equipment or engage in or observe shooting and other activities at the RANGE. I further agree to accept financial responsibility for the repair of any equipment that I borrow or use that is owned by the CLUB if damages were directly caused by MINE or my GUEST's inappropriate use of said equipment.

#### **GUARDIANSHIP of MINORS**

IN CONSIDERATION of allowing the below MINOR participant in activities on the RANGE and/or being permitted to enter for any purpose any AREA of the RANGE (defined as any area requiring special authorization, credentials or permission to enter or any area to which admission by the general public is restricted or prohibited, including but not limited to the shooting bay area, the retail areas, waiting areas and any other area of the CLUB property), EACH OF THE UNDERNAMED, his/her personal representatives, heirs, assigns, and next of kin agrees to all provisions set forth in this "Release - Assumption of Risk Agreement:"

I have carefully read this "Release – Assumption of Risk Agreement" and fully know its contents. I acknowledge that no other inducement, assurance or guarantee has been made to me in consideration of my signing this Agreement which I sign voluntarily and of my own free will. I further acknowledge and agree that this Agreement may be amended or modified only by a writing signed by me and by an authorized agent of the CLUB. The "Release, Assumption of Risk" is valid for the calendar year set forth above.
